What's Next With Our Documents?

Our HOA Documents were created in 2000. They were modeled from an existing HOA. The laws for homeowner associations have changed and will continue to change. As a result, it is necessary to maintain our documents as current.

The five committee members who have seen the project through to completion are: Ken MacHold, Don Baker, Lois Schladale, Jenyne Weingart and Cathy MacHold. Committee was tasked with providing improvements in the language, removing outdated statements, and making suggestions which then went back to the attorneys for additional legal updates. It was returned from the attorneys for committee review and additional comments. Then it was updated in an electronic file. Currently the CC&Rs, the By-Laws and the Architectural Rules are in preliminary review with Angius & Terry LLP.

The next phase is a HOA community meeting with Angius & Terry for input, questions and answers before the final certification of the Documents. We hope this will happen sometime in March.

So, where do we go from here?

Step 1: Mutual respect
