Land Trust Weed Abatement

Last fall the Placer Land Trust applied chemicals to their trails adjacent to our neighborhood to kill off the weeds so that they would not overtake the trails. They gave no warning that this was going to occur. Many people from the neighborhood and from the access up at Bowman hike through the area and many walk their dogs on the trails. This presented a health concern to me as a hiker and dog owner. I called the PLT and explained my concern and asked them to post a notice in advance of any spraying to be done this year. They apologized for not providing notification last year and indicated they would do so this year. I will be following up. Dick Freeman

We currently have a Special Assessment out for your vote and approval. I know it is not anything that anyone wants, especially at this time of the year, but it is essential. I certainly hope it's not a surprise, we have been talking about this for 6-8 months at community meetings, Board meetings, social gatherings, etc. The funds are needed to pay our short term debt. Moving into 2019, we have a plan to rebuild. First step is getting rid of the lawyers. Second step is a commitment to work together to resolve our differences. Third step is civility and respect for everyone.

More on our View Corridor

The View corridor language is woven into thoughtful attention in Architectural Guidelines. Responsibility for maintaining the outstanding character of Canyon View Estates for all residents is that of the owners themselves, acting through the Homeowners Association. The View Corridor is partially defined as the view from any location in Canyon View Estates, an individual owner's property from a window, a deck, a patio, or a walk through the neighborhood that unobstructed from tree height, obstructive fencing, recreational vehicle parking or anything else considered to block or diminish the view. As we work through our documents, the ACC has realized how often the language of our view corridor is mentioned. We are proud that the document creators took such pride and consideration into our CC&R's and Architectural Guidelines.



Keeping Canyon View Unique and Beautiful



Enjoy the nightscape and stars and minimize light pollution by turning off outdoor lighting after 10PM.



Flying Drones in Canyon View Estates is prohibited except for use when selling your home.

State Regulations – Current & Pending

Amended Civil Code § 1708.8 protects the privacy of the "airspace above the land of another person." Flying a drone or model aircraft in the "airspace" above someone else's property is punishable by up to \$50,000 in fines. Other pending legislation require pilots to identify their aircrafts with specific information and avoid using them above public schools.

Proposed Bill, AB 1662, requires anyone flying an unmanned aircraft system involved in an accident that causes injury to someone else or their property to immediately land it and provide valid ID to the person or property owner. Not doing so could result in a misdemeanor.
